

INFORMATION ON THE OWNERSHIP AND PROCESSING OF PERSONAL DATA

In connection with the application of European Union regulations on the protection of personal data (GDPR), we hereby inform you about the processing of your personal data and the principles governing such processing.

Pursuant to Article 13(1) and (2) of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (GDPR), we inform you that the controller of your personal data is Garden Parts Sp. z o.o., based in Warsaw (ul. Nowogrodzka 31, 00-511 Warsaw, NIP: 701-034-91-62, KRS: 000043421).

Personal data is processed for the following purposes:

- to fulfill placed orders,
- to carry out marketing activities, in particular to provide information about offers, promotions, and news.

Your personal data may be shared with third parties cooperating with the controller in the order fulfillment process, in particular companies providing accounting, transport, and IT services.

The scope of processed personal data corresponds to the information provided by you in the registration form when signing up for the online ordering system on the website www.gardenparts.pl. This data is available after logging into your user account in the "My Profile" section.

The consent given during registration for the processing of personal data meets the requirements of applicable data protection regulations, including the GDPR, and remains valid until withdrawn.

We inform you that you may withdraw your consent at any time. You have the right to access your personal data, rectify it, delete it, or restrict its processing. Consent is voluntary, and its withdrawal may be made at any time, in whole or in part, by sending a request to the email address info@gardenparts.pl. Withdrawal of consent may make further use of the services or continuation of cooperation impossible.

Personal data will be deleted without undue delay, and no later

than within the legally required periods, subject to cases where further processing is required by law.

Providing this consent is voluntary. In the event that consent is not given, the following provisions of the GDPR shall constitute the legal basis for processing:

* Art. 6(1)(b) – processing is necessary for the performance of a contract between the parties,

* Art. 6(1)(f) – processing is necessary for the purposes of the legitimate interests pursued by the company after termination of the contract, in particular for settlements and for pursuing claims until the expiry of the limitation period.

We inform you that your personal data will not be transferred to third countries or international organizations.

Data is stored in a form that allows identification of the data subject, but no longer than necessary for the purposes for which it is processed, taking into account statutory retention periods, in particular in connection with the pursuit of claims and the fulfillment of service obligations.

You have the right to request access to your personal data, its rectification, permanent deletion, restriction of processing, or data portability - and the company will comply with such requests provided that legal requirements are met.

Personal data is processed in accordance with Regulation (EU) 2016/679 (GDPR), Official Journal of the EU L 119/1 of 04.05.2016, as well as national data protection law and the Act of 18 July 2002 on the provision of electronic services.
